- 38 of 38 Wyoming nursing homes joined the Collaborative
 - Exceeded CMS Goal of 75%
 - Only 2 states reached 100%
 - Wyoming
 - Alaska
 - 100% of WY Nursing Homes completed QAPI Self-Assessments for Collaborative I and II
 - All showed progression in the development of QAPI Program



- NHSN Nursing Home CDI Reporting Project:
 - Recruitment
 - CMS target number = 6
 - WY recruitment number = 10
 - Baseline Reporting
 - 8/10 nursing entered 10 months of data for baseline
 - WY Total Baseline (CO/FO) = 0.413
 - National Baseline (CO/FO) = 0.652
 - WY Total Baseline (FO only) = 0.354
 - National Baseline (FO only) = 0.413
 - Remeasurement Reporting-ends 12/2018

- Antipsychotic medication utilization QM rate:
 - Goal: 15% RIR by 1/2019
 - WY Baseline rate (Q1-Q4 2013): 17.49%
 - Current Rate: 13.03% (lowest rate was 12.48)
 - Current RIR: 25.52%
 - Will this continue to be a focus for CMS?
 - YES!!! At least through 12/2019



- WY Collaborative NHs reaching a Composite Score rate of ≤ 6%
 - CMS Target: 50% of the 75% Required Recruitment Goal (50% of 28 = 14 Nursing Homes)
 - 1Q2018 = 16 Nursing Homes Achieved or 59%
 - Measurement ends 3Q2018
 - Several very close to achieving


