Pat Fritz has received the distinguished Daniel J. Lex award for outstanding service in long-term care, given by LeadingAge Wyoming. The Daniel J Lex award is given to an individual that has devoted their life and career to providing high quality long-term care and to improving quality of life for those that receive their care in a long-term care setting.

Pat Fritz, RN, BC, WCC, NHA has over 35 years of experience in the long-term care community as a staff nurse, educator, regulator, director of nursing, nursing home administrator, and consultant.
