

## Wyoming Nursing Homes Receive Quality Health Care Awards

Mountain Pacific is proud to announce the Wyoming recipients of the 2023 Nursing Home Quality Awards. This year's award criteria were based on a quality measure point system that included decreasing adverse drug events, preventing infection, decreasing readmissions, improving resident vaccination rates for influenza and pneumococcal vaccines and a bonus category that acknowledged nursing homes that were never referred to Mountain Pacific from the Centers for Medicare & Medicaid Services for a COVID-19 outbreak.

Five Wyoming long-term care facilities met these goals and received their awards during the Wyoming Hospital Association conference held by Leading Age Wyoming in Cheyenne on Wednesday, August 30.

One facility received the Excellence in Quality Award, the top award South Lincoln Nursing Center

Four facilities received the Achievement in Quality Award:

## CMS Issues Proposed Rule on Minimum Staffing in Nursing Homes

The Centers for Medicare & Medicaid Services Sept. 1 issued a **proposed rule** regarding staffing requirements for nursing homes that participate in Medicare and Medicaid. CMS estimates that about 75% of nursing homes would have to increase staffing in their facilities under the proposed standards, which exceed those existing in nearly all states.

Comments on the rule are due 60 days after it is published in the Federal Register.

As proposed, the policy would:

- require nursing homes to provide a minimum of 0.55 hours of care from a registered nurse per resident day and at least 2.45 hours of care from a nurse aide per resident day;
- implement and enforce standards, regardless of individual facilities' patient case mix;
- require an RN to be on-site at all times; and
- revise requirements to the content of nursing home care assessments.
